New! Lifeways receives CCBHC grant award

This morning LifeWays Community Mental Health received notification from the Department of Health and Human Services Substance Abuse and Mental Health Services Administration (SAMHSA) Center for Mental Health Services for the LifeWays Certified Community Behavioral Health Clinic (CCBHC) project.

This grant award comes after seven full years of dedicated work by LifeWays' Board, staff and administration toward CCBHC readiness, and the timing couldn't have been better. On January 25 LifeWays completed Phase 2 of its building remodel to make necessary capital improvements needed for the change in our business model for a 24/ 7 crisis unit. (Last year, we completed Phase 1 for integrated health.) Our crisis unit can now offer a continuum of services on site, 23-hour observation, intensive mobile crisis services, adult mobile crisis, crisis residential and screening and referral services.

New! NIDA & NIH issue set of SUD resources and announcements

Below are a set of resources and announcements recently issued by the Office of Science Policy and Communications, National Institute on Drug Abuse/National Institutes of Health

Dr. Volkow's (Director of NIDA) most recent [blog](#) discusses the results of the [recently published](#) NIDA-supported Phase III clinical trial finding that a combination of injectable naltrexone and oral bupropion was safe and effective in treating adults with moderate or severe methamphetamine use disorder.

Research conducted by NIDA and [published](#) in JAMA Psychiatry found that methamphetamine overdose deaths surged in an eight-year period in the United States.

A NIDA-supported study [published](#) in Addiction found that a collaborative approach to treating opioid use disorder that relies heavily on community pharmacists is feasible and may increase adherence and participant satisfaction.

SAMHSA released a new guide, [Use of Medication-Assisted Treatment in Emergency Departments](#), that examines emerging and best practices for initiating medication-assisted treatment in emergency departments. It also reviews the existing literature and science of the topic, identifies gaps in knowledge, and discusses challenges of implementation.

New! House Passes COVID Supplemental Bills

This week, the Michigan House of Representatives took up and passed – along party lines – FY 2020-21 COVID-19 supplemental appropriations bills, including:

- House Bill 4019 (H-3) makes appropriation adjustments for the Michigan Department of Health and Human Services (MDHHS) and the Department of Labor and Economic Opportunity (LEO) - \$868 million; which included the following key items:
 - Substance Abuse Prevention and Treatment Block Grant Includes authorization to receive an additional \$13.1 million in newly awarded federal block grant funding.
 - Mental Health Block Grant Includes authorization to receive an additional \$12.0 million in newly awarded federal block grant funding.
- House Bill 4047 (H-2) makes an appropriation adjustment to LEO and the Treasury budget for FY 2020-21, including \$565.5 million in general fund revenue to assist businesses hardest hit by the pandemic;
- House Bill 4048 (H-1) includes a \$1.8 billion increase in federal funds from the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act for schools, including incentives for schools districts that offer in-person instruction (Note: tie-barred to HB 4049);
- House Bill 4049 (H-1) would amend the Public Health Code to curtail the DHHS Director's ability to issue emergency public health orders that would suspend in-person education or prohibit sporting events during a pandemic. Instead, local health officials would take responsibility for closing schools or prohibiting sporting events should COVID-19 cases increase and meet specific thresholds deemed unsafe for the community to continue in-person education or sports (Note: tie-barred to HB 4048).

There were no amendments adopted on the House floor, despite several attempts by Democrats to amend the measures, and impassioned floor speeches around the need to expend all of the federal funding that has been made available to Michigan.

The bills now advance to the Senate where their fate right now is uncertain.

DHHS EMERGENCY ORDERS

Today, Governor Whitmer announced the finalization of the Feb. 1 reopening of indoor dining for restaurants and bars, but with a 10 p.m. curfew and a 25% capacity limit, up to 100 people.

Large stadiums will also be allowed more capacity to allow for additional attendance at high school football finals being hosted this weekend, under the newest epidemic order issued by the Michigan Department of Health and Human Services (DHHS) that will take effect Feb. 1 and run until Feb. 21.

The new capacity limits allow for 500 people at venues that seat over 10,000 people, while stadiums that seat less than 10,000 are allowed to be at 20% capacity, up to 250 people.

The order also will allow concessions at casinos, movie theaters and stadiums; personal services requiring mask removal and non-residential gatherings of up to 10 people from two households.

Executive Orders Signed

Currently, Governor Gretchen Whitmer has signed over 170 Executive Orders in response to COVID-19. Below is the most recent list of Executive Orders with the topic and a hyper link accessing the Executive Order below.

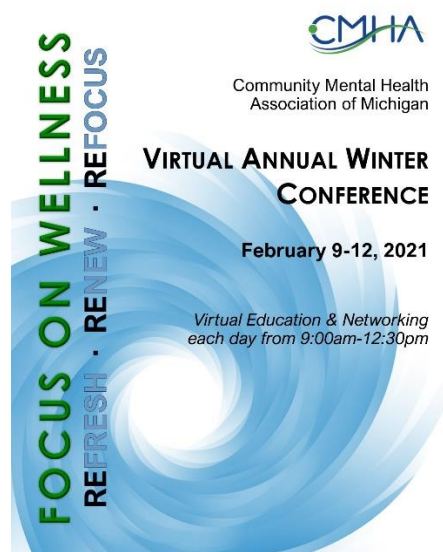
Federal Update

House Passes Short-Term Federal Funding

This week, the House of Representatives passed a short-term continuing resolution (CR) through December 18 to provide appropriators with additional time to reach a spending agreement for fiscal year (FY) 2021. The CR also includes provisions that would extend several expiring health care policies, including Certified Community Behavioral Health Clinics (CCBHCs). The Senate now has until midnight tonight to vote on the CR to avert a shutdown.

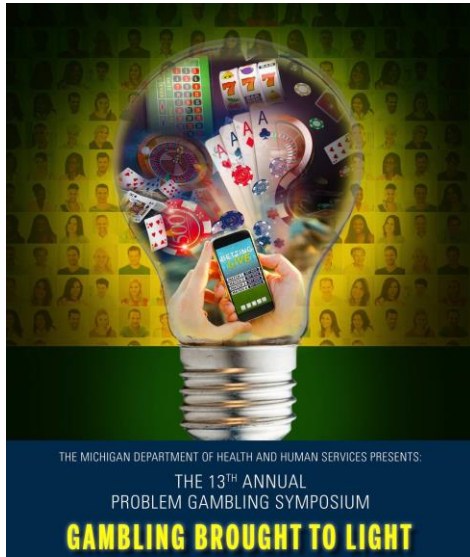
